ABOUT THE TECHNOLOGIES

DeVita technologies are based on bio-resonance therapy methods developed by Russian and foreign scientists. They work on two basic principles:

Helmut Schimmel

Before Schimmel, the condition of the organs were measured via different points. Now only one "reproducible" point is the source of information and the drug-indicators are tested directly at this point.

THE HOMO-TOXICOSIS THEORY OF DR. RECKEWEG




Heinz Heinrich Reckeweg,



PRINCIPLE OF OPERATION

DeVita technologies are based on eradiation of super-weak electromagnetic waves which influence the whole body and individual organs due to the bio-resonance effect. The bio-resonance is strengthening the natural oscillations of organs due to electromagnetic waves of the same frequency. Bio-resonance eradiation of the DeVita devices can be estimated by an oscillograph, the instrument for monitoring and measuring the electromagnetic waves.

В соответствии с условиями "Договора", "Исполнитель" по заданию "Заказчика" провел оценку эффективности прибора «DeVita RITM, DeVita AP, DeVita ENERGY».

Условия проведения исследования:

- Для исследования взято 20 образцов сыворотки крови больных терапевтического, эндокринологического, педнатрического, дерматовенерологического и гастроэнтерологического отделений многопрофильного научно-клинического института г. Москвы.
 - Сыворотка крови каждого пациента разделена на 6 пробирок по 100 мкл;
 - 0 контроль (без воздействия);
 - 1 общий режим;
 - 2 режим улучшения кровообращения;
 - 3 режим детоксикации;
 - 4 режим «Лимфодренаж»;
 - 5 режим повышения уровня энергии.
- На каждый образец сыворотки крови (всего 600) было оказано электромагнитное воздействие аппаратом «DeVita RITM, DeVita AP, DeVita ENERGY» по заложенным в нём различным программам.
- 4. После электромагнитного воздействия, методом клиновидной дегидратации покальную организацию непосредственно после воздействия электромагнитным полем, и спустя сутки после воздействия. Полученные результаты сравнивали с контрольными образцами (группа 0).

Результаты исследований

Изучены морфологические особенности фаций сывороток крови 20 пациентов в контрольных образцах и после воздействия на них пяти режимов. Сняты 620 микрофотографий в частично-темном поле и в обычном свете при разных увеличениях стереомикроскопа МZ12 фирмы "Leica" (х10 – х80).

EVALUATION RESULTS

Опенка изменений структуры сыворотки крови проводилось по динамике трех морфологических маркеров: хронической интоксикации, воспаления и активации микроциркуляторного русла.

Установлено, что системная организация сыворотки крови всех пациентов проявляла отклик на действие внешнего волнового источника. При этом, структуры сыворотки крови большинства пациентов демонстрировали определённую динамику маркеров после воздействия соответствующего режима:

- морфологические признаки интоксикации при использовании режимов 1, 3, 4 и 5 исчезали или их проявление значительно снижалось;
- маркер активации микропиркуляторного русла статистически значимо выявлялся при воздействии на сыворотку крови режимов 2 и 5;
- маркер воспаления в качестве ответной реакции сыворотки крови на воздействие наиболее четко выявлялся после воздействия режима 5.

Таким образом, волновое электромагнитное воздействие в пяти режимах на сыворотку крови человека показало соответствие изменения структуры сыворотки крови заданному терапевтическому назначению определённого волнового спектра прибора.

Заключение:

- Annapat «DeVita RITM, DeVita AP, DeVita ENERGY» оказывает отчетливое влияние на структуру сыворотки крови (по результатам анализа фаций);
- Характер структурных изменений сыворотки крови соответствует заданным терапевтическим режимам настройки аппарата.
